

1. Overview

Abcam's Rat IL-6 ELISA (Enzyme-Linked Immunosorbent Assay) kit is designed for the quantitative measurement of rat IL-6 in plasma or cell culture supernatants. Due to the relatively low abundance of IL-6 in normal rat plasma, this kit may not be suitable for use with this sample type. We have not been able to detect endogenous Rat IL-6 in normal serum with ab100772, only in serum spiked with Rat IL-6.

This assay employs an antibody specific for Rat IL-6 coated on a 96-well plate. Standards and samples are pipetted into the wells and IL-6 present in a sample is bound to the wells by the immobilized antibody. The wells are washed and biotinylated anti-Rat IL-6 antibody is added. After washing away unbound biotinylated antibody, HRP-conjugated streptavidin is pipetted to the wells. The wells are again washed, a TMB substrate solution is added to the wells and color develops in proportion to the amount of IL-6 bound. The Stop Solution changes the color from blue to yellow, and the intensity of the color is measured at 450 nm.

2. Protocol Summary



Prepare all reagents, samples, and standards as instructed.

3. Precautions

4. Storage and Stability

Store kit at -20°C immediately upon receipt. Kit has a storage time of 1 year from receipt, providing components have not been reconstituted.

5. Limitations

- Assay kit intended for research use only. Not for use in diagnostic procedures.
- Do not mix or substitute reagents or materials from other kit lots or vendors. Kits are QC tested as a set of components and performance cannot be guaranteed if utilized separately or substituted.

7. Materials Required, Not Supplied

These materials are not included in the kit, but will be required to successfully perform this assay:

- Microplate reader capable of measuring absorbance at 450 nm.
- Precision pipettes to deliver 2 µL to 1 mL volumes.
- Adjustable 1-25 mL pipettes for reagent preparation.
- 100 mL and 1 liter graduated cylinders.
- Absorbent paper.
- Distilled or deionized water.
- Log-log graph paper or computer and software for ELISA data analysis.
- Tubes to prepare standard or sample dilutions.

8. Technical Hints

- Samples generating values higher than the highest standard should be further diluted in the appropriate sample dilution buffers.
- Avoid foaming or bubbles when mixing or reconstituting components.
- Avoid cross contamination of samples or reagents by changing tips between sample, standard and reagent additions.
- Ensure plates are properly sealed or covered during incubation steps.
- Complete removal of all solutions and buffers during wash steps.
- When preparing your standards, it is very critical to briefly spin down the vial first. The powder may drop off from the cap when opening it if you do not spin down. Be sure to dissolve the powder thoroughly when reconstituting. After adding Assay Diluent to the vial, we recommend inverting the tube a few times, then flick the tube a few times, and then spin it down; repeat this procedure 3-4 times. This is a technique we find very effective for thoroughly mixing the standard without too much mechanical force.
- Do not vortex the standard during reconstitution, as this will destabilize the protein.
- Once your standard has been reconstituted, it should be used right away or else frozen for later use.
- Keep the standard dilutions on ice while during preparation, but the ELISA procedure should be done at room temperature.
- Be sure to discard the working standard dilutions after use they do not store well.
- This kit is sold based on number of tests. A 'test' simply refers to a single assay well. The number of wells that contain sample, control or standard will vary by product. Review the protocol completely to confirm this kit meets your requirements. Please contact our Technical Support staff with any questions.
- Selected components in this kit are supplied in surplus amount to account for additional dilutions, evaporation, or instrumentation settings where higher volumes are required. They should be disposed of in accordance with established safety procedures.

9. Reagent Preparation

- Equilibrate all reagents to room temperature (18-25°C) prior to use.
 The kit contains enough reagents for 96 wells.
- Prepare only as much reagent as is needed on the day of the experiment.

9.1 1X Assay Diluent B

5X Assay Diluent B must be diluted 5-fold with deionized or distilled water prior to use.

9.2 1X Wash Solution

If the 20X Wash Concentrate contains visible crystals, equilibrate to room temperature and mix gently until dissolved. Dilute 20 mL of 20X Wash Buffer Concentrate into deionized or distilled water to yield 400 mL of 1X Wash Buffer.

9.3 1X Biotinylated IL-6 Detection Antibody

Briefly spin the Biotinylated anti-rat IL-6 vial before use. Add 100 μ L of 1X Assay Diluent B into the vial to prepare a detection antibody concentrate. Pipette up and down to mix gently (the concentrate can either be stored at 4°C for 5 days or aliquoted and frozen at -20°C for 2 months). The detection antibody concentrate must be diluted 80-fold with 1X Assay Diluent B prior to use in the Assay Procedure.

9.4 1X HRP-Streptavidin Solution

Briefly spin the 400X HRP-Streptavidin concentrate vial before use. HRP-Streptavidin concentrate must be diluted 400-fold with 1X Assay Diluent B prior to use in the Assay Procedure.

For example: Briefly spin the vial and pipette up and down to mix gently. Add 30 μ L of 400X HRP-Streptavidin concentrate into a tube with 12 mL 1X Assay Diluent B to prepare a final 400-fold diluted 1X HRP-Streptavidin solution. Mix well.

10. Standard Preparation

- Prepare serially diluted standards immediately prior to use. Always prepare a fresh set of standards for every use.
- Discard working standard dilutions after use as they do not store well.
- Standard should be stored at -80°C after reconstitution.
- The following section describes the preparation of a standard curve for duplicate measurements (recommended).
- 10.1 Prepare Standard #1 by adding 500 µL of Assay Diluent C into the vial of the rat IL-6 standard to produce 10 ng/ml of stock standard solution.
- 10.2 Dissolve the powder thoroughly by gentle mixing.
- 10.3 Label tubes #1-8.
- 10.4 Pipette 300 µL Assay Diluent C into each tube.
- 10.5 Prepare Standard #2 by transferring 200 μ L from tube #1 to #2, mix thoroughly.
- 10.6 Prepare Standard #3 by transferring 200 μ L from tube #2 to #3, mix thoroughly.
- 10.7 Using the table below as a guide, prepare further serial dilutions.
- 10.8 Assay Diluent C serves as the zero standard (0 pg/mL).

11. Sample Preparation

General Sample Information:

- If your samples need to be diluted, Assay Diluent C should be used for dilution of plasma, cell culture supernatants and urine.
- Suggested dilution for normal plasma: 2 fold.
- Please note that levels of the target protein may vary between different specimens. Optimal dilution factors for each sample must be determined by the investigator.

12. Plate Preparation


- The 96 well plate strips included with this kit are supplied ready to use. It is not necessary to rinse the plate prior to adding reagents.
- Unused well strips should be returned to the plate packet and stored at 4°C.
- For statistical reasons, we recommend each sample should be assayed with a minimum of two replicates (duplicates).
- Well effects have not been observed with this assay. Contents of each well can be recorded on the template sheet included in the Resources section.

13. Assay Procedure

- Equilibrate all materials and prepared reagents to room temperature prior to use.
- We recommend that you assay all standards, controls and samples in duplicate.
- 13.1 Add 100 µL of each standard (see Standard Preparation section 10) and sample into appropriate wells. Cover well and incubate for 2.5 hours atroom temperature or over night at 4°C with gentle shaking.
- 13.2 Discard the solution and wash 4 times with 1X Wash Solution. Wash by filling each well with 1X Wash Solution (300 µL) using a multi-channel Pipette or autowasher. Complete removal of liquid at each step is essential to good performance. After the last wash, remove any remaining 1X Wash Buffer by aspirating or decanting. Invert the plate and blot it against clean paper towels.
- 13.3 Add 100 μ L of 1X Biotinylated IL-6 Detection Antibody (Reagent Preparation section 9) to each well. Incubate for 1 hour at room temperature with gentle shaking.
- **13.4** Discard the solution. Repeat the wash as in step 13.2.
- 13.5 Add 100 µL of 1X HRP-Streptavidin solution (see Reagent Preparation section 9) to each well. Incubate for 45 minutes at room temperature with gentle shaking.
- 13.6 Discard the solution. Repeat the wash as in step 13.2.
- 13.7 Add 100 μL of TMB One-Step Substrate Reagent to each well. Incubate for 30 minutes at room temperature in the dark with gentle shaking.
- 13.8 Add 50 μ L of Stop Solution to each well. Read at 450 nm immediately.
- 13.9 Analyze the data as described below.
- 13.9.1 Calculate the mean value of the duplicate or triplicate readings for each standard and sample.
- 13.9.2 To generate a standard curve, plot the graph using the standard concentrations on the x-axis and the corresponding mean 450 nm absorbance (OD) on the y-axis. The best-fit line can be determined by regression analysis using log-log or four-parameter logistic curve-fit.
- 13.9.3 Determine the unknown sample concentration from the Standard Curve and multiply the value by the dilution factor.

14. Typical Data

Typical standard curve – data provided for demonstration purposes only. A new standard curve must be generated for each assay performed.

18. Troubleshooting

Problem	Reason	Solution
Poor standard curve	Inaccurate pipetting	Check pipettes

	Improper standard dilution	Prior to opening, briefly spin the stock standard tube and dissolve the powder thoroughly by gentle mixing
	Incubation times too brief	Ensure sufficient incubation times; increase to 2 or 3 hours standard/sample incubation
Low signal	Inadequate reagent volumes or improper dilution	Check pipettes and ensure correct preparation
Large CV	Inaccurate pipetting	Check pipettes
High	Plate is insufficiently washed	Review manual for proper wash technique. If using a plate washer, check all ports for obstructions
background	Contaminated wash buffer	Prepare fresh wash buffer
Low sensitivity	Improper storage of the ELISA kit	Store the reconstituted proteins at -80°C, all other assay components 4°C. Keep substrate solution protected from light.
